“Updated Rabies Vaccination and License Law

Broward County law requires an *annual* license and *current* rabies vaccination certificate. A recent change

in the County ordinance now allows pet owners the option of a 12-month or three (3) year rabies re-vaccination. Newly vaccinated pets are required to be re-vaccinated 12-months after the initial vaccination.”

This change in the law is wonderful news for our dogs!

Unique Story -----

Twister the Hero

as told by Charlotte Hulett

[Editor's preface: At the time of this story, Twister was ten month's old and, of course, is a sheltie. Story unfolds in House Springs, Missouri.]

This morning [March 17, 2006] when Kacie came in to drop Twister off, she said: "Grandma, Twister is a Hero. I'll tell you about it this evening." – She had a big smile on her face, so all day I was thinking that she would be telling me about something cute that he did, that made him a "Hero."

When she came home this afternoon and told us the story, it turns out that he really is a HERO!

Last night, at 1:00 in the morning, he woke Kacie up whining and jumping against her bed. She tried to shush him, but he wouldn't quit. He kept getting louder and more upset. Finally Kacie woke up enough to hear that there was a noise outside. At first she thought it was an animal in distress, or animals fighting, and was just going to go back to sleep, as she didn't want to go out in the middle of the night, not knowing what kind of animals there were out there.

By this time, Twister is jumping on the bed and jumping on her, and refusing to let her go back to sleep. The noise outside got louder, and Kacie decided that she would at least go look out the front door. When she opened the door, she saw a small child standing across the street from her house, in the middle of street, screaming. -- She went out, looked around, and saw no one else. She went and got the little boy and took him into her house. He was dressed in a sleeper, but had no shoes on and it was quite cold last night. He was shivering and crying. She held and comforted him and tried to see if he could tell her which was his house. But he was only about a year and a half old, and didn't know which house was his. -- Kacie had never seen him before and had no idea whose child he was.

She was puzzled about what to do, then decided to call 911. When she was on the phone with them, there came a knock at her door. It was the little boy's parents. *Their* dog had woke *them* up, and when they got up to go see what was wrong with him, (he was an outside dog) they saw their front door open. They didn't know if a burglar had broken in or what. The first thing they did was run to the little boy's room to check on him and he wasn't there.

When they went outside to look for him, they saw Kacie's lights on and went to her house to see if she had seen anything. When they knocked on her door, she didn't know whether to answer it or not, but decided she probably ought to see who it was. Mom, Dad, and baby then had a happy reunion.

So, it was a happy ending, but might not have been if it hadn't been for Twister, and also the other people's dog, as evidently no people had heard the little boy crying. --

Just the dogs! As cold as it was, he could have died from hypothermia if not for the dogs alerting their people that there was something wrong!

[Editor's update: This is the second puppy from the same litter to do a "rescue." The other puppy, a female, went to a family in which the mom has diabetes. The mom got up one night in the middle of the night not feeling well, started into the kitchen, fainted, and fell in the living room unconscious. The puppy woke up the rest of the family and they found her. She had gone into a diabetic coma and could have died if they had not found her when they did! Aren't shelties wonderful?]

March General Membership Meeting Minutes -----

MINUTES OF THE MONTHLY MEETING Home of Stephanie Trautman-Riley Davie, Florida March 14, 2006

President Stephanie Trautman-Riley declared a quorum present and called the meeting to order at 8:20 p.m. at her home in Davie, Fl., on Tuesday, March 14, 2006. In addition to the President, members present included Christine Smith, Martha Hollingsworth, Meta Hollingsworth, Cindi Theiss, Hector Hector, Colleen Kessler, Paul Zaryczny, and Meredith Hector. Prospective member Mark Hussard (guest of Colleen Kessler) also attended – this was his second meeting.

Stephanie asked if anyone had corrections to the February 2006 meeting minutes as published in the newsletter. None were suggested. The minutes were approved unanimously.

Officer Reports

President

Stephanie read a letter she had written to the membership expressing her gratitude for the opportunity and privilege of serving as President this past year. She also expressed her appreciation for everyone's hard work, dedication, commitment and contributions to the club's impressive and hugely successful specialty show.

Secretary

Due to a family emergency, Lorna was unable to attend the meeting or to submit a report.

Vice President

Jana was unable to attend the meeting or provide a report due to her continuing recuperation from her surgery. The members present continue to wish for her speedy recovery and look forward to her next report when she is able to present it.

Treasurer

Colleen distributed a variety of reports including the February 2006 bank statement and a breakdown of income and expenses related to the specialty show – one for 2006 and one from the start of our planning and payments dating back to 2005. The reports and statements indicated that the show did make a profit and that our current bank balance is nearly twice the size that it was in January.

Colleen noted that there were two KV Vet supply certificates left over from the show for classes in which there was no competition. The certificates do not have an expiration date. After discussion, it was decided that the certificates should be used for a future event such as an Olympics, match or puppy picnic.

Committee Reports

Newsletter – no report

Website – no report

Breeder referral – no report

Show

Paul stated that he was extremely proud of the show and of all the people who made it happen. He said everyone did a tremendous job and extended his thanks to all the members who contributed.

The following matters related to the show were then addressed:

1. *Mileage reimbursement for Captain Haggerty* - Captain Haggerty was to judge our sweepstakes on Sunday. Due to an auto accident and detour, he got lost on his way to the show site, arrived late, and was only able to judge veteran sweepstakes. As a result of being lost, he traveled several miles beyond what was expected. He was not requesting reimbursement for the additional mileage but Paul did want to know if the club felt he should be reimbursed for all the miles he traveled or only those he should have traveled had he not gotten lost. After discussion it was determined that he should only be reimbursed for what he would have traveled had he not gotten lost.
2. *Judge's gift for Ana Whiting* – Paul felt it appropriate that Ana Whiting receive a gift for stepping in to judge puppy sweepstakes on Sunday. There was unanimous agreement by the members present. An American Express gift certificate will be sent to her along with a note of appreciation for the outstanding job she did and for being such a good sport to step in unexpectedly and at the last moment.
3. *Thank you letters* – Paul asked that thank you letters be sent to the 4-H volunteers for their efforts on Sunday. Stephanie agreed to send these letters if Paul got her their names and addresses. She has already had nice thank you cards made up with the SSCSEF logo printed on them and plans to send cards to the judges and to all the advertisers (who will also get a copy of the catalog featuring their ad).
4. *Missing ad* – it was brought to Paul's attention that the full page ad featuring the signatures of many club members was missing from the catalog. It may have been a printer error. The members who paid for that page will be reimbursed.

5. *Trophies and ribbons* – Stephanie noted that the trophies and ribbons were well received. She apologized for the glitch regarding veterans' ribbons for the regular classes Saturday. No dog won High Combined on Saturday so the suitcase will go into storage for use at a future event. Also, there is box of rosettes left over. They can be reused. All we need to do is remove the center ribbon and replace with a new one with the correct date printed on them. The company will provide those at a nominal cost.
6. *Raffle* – Hector reported that the raffle drew nearly \$1,000 in revenue for the club. He thanked all those who donated and solicited items and bought tickets.
7. *General suggestions/notes for future shows* –
 - There was consensus among those present that the back-to-back show was worth doing again. The park was a hit but it was agreed that the club will need to review dates and locations to keep and consider all options.
 - Chris suggested that we use a pre-order form be put in the premium list for hospitality to better gauge quantity and make less work for those handling food ordering and serving
 - As acting show secretary Holly was in a position to receive and hear lots of compliments and suggestions first hand on many aspects of the show:
 - Entry fees – make costs easier to calculate – especially non-regular class entries
 - Judging start time – staggered start between conformation and obedience/ rally was a huge help
 - Trophies -should be displayed at the ring at which they will be awarded rather than centrally to ease workload for stewards and trophy chair. Also, stewards need a list in advance of all awards to be given
 - Cash awards - were VERY well received, recommended that we offer again
 - Bait - greatly appreciated. There was a request that it be in larger pieces and drier if possible
 - Catalogs - also VERY well received. Lots of compliments on how beautiful they were and how many ads were in them. We can probably order fewer the next time around
 - Ring stewards – a practice run through will probably be helpful
 - Judges gifts – all judges delighted with the American Express gift certificates; it is recommended that we get them again in the future
 - Show logo – folks loved it, had exhibitors requesting t-shirts. Club should explore getting these made and selling them for a profit
 - All breed obedience and rally suggested by exhibitors and judges as a means to boost entries; if entries are large enough would suggest one ring for each; judges were also kind enough to provide a list of prospective judges for next year
 - Location
 - need site or must work with existing site to ensure ONE set-up and take down of equipment
 - viable RV parking would be a huge benefit/draw

- Possibility of combining our show with other sheltie clubs (new 200 mile rule now in effect) should be explored
 - Venue (indoor vs. outdoor) tied to time of year
- Judging program/entry confirmation – needs to provide additional information like hotel directory, rules and regulations, food order forms, etc.
- Discrepancies in payments (over and underpayments) need to be handled differently in the future so folks aren't inadvertently embarrassed or made to pay when they are attempting to walk in the ring

Martha gave an update on the herding instinct testing with Judith Kelly. The cost is \$45 per dog and is limited to 10 dogs. Each dog gets two exposures to the stock. The event would be held on a Sunday in Malabar, FL (north of Vero Beach). Most likely the date will be in May. Sign -up will be on a first come, first serve basis on the web site or through Martha.

New Business

Hector informed the members present that the next meeting would take place on Tuesday, April 11, 2006 at the Elks Lodge in Pompano Beach (pending final confirmation from Dorothy Moore). A meeting of the board will also be scheduled prior to the general membership meeting.

At 9:45 p.m., with no further business, Paul moved that the meeting be adjourned. Meta seconded the motion which passed unanimously.
