Club Information-----

Constitution and Bylaws: Due to the difficulty of obtaining a quorum at recent club meetings, it has been discussed that changes to our Bylaws may be appropriate at this time. Therefore, the following changes are being considered and will be voted on at the September general membership meeting or the next meeting thereafter at which there is a quorum:

Article II – Membership

Section 1. Eligibility. – [no change].

- a) Full Membership [no change].
- b) Associate Membership [no change].
- c) Junior Membership [no change].
- d) Lifetime Membership Lifetime membership is reserved for a select number of members who have demonstrated extraordinary dedication to the Club through their length of membership and exceptional service record <u>and who</u> <u>currently attend two or more meetings in a calendar year</u>. Such individuals will have been a club member for twenty or more years and provided outstanding contribution to the Club. <u>Lifetime members are entitled to all</u> <u>privileges of the Club, including voting and holding office, but pay no dues.</u>
- e) <u>Associate Lifetime Membership Associate lifetime membership is reserved</u> for a select number of members who have demonstrated extraordinary dedication to the Club through their length of membership and exceptional service record and who currently attend less than two meetings in a calendar year. Such individuals will have been a club member for twenty or more years and provided outstanding contribution to the Club. Associate Lifetime members pay no dues, are not eligible to vote or hold office, do not count towards a quorum for the conduction of business, but are entitled to all other privileges of the Club.

Only full members may nominate others for lifetime membership or be nominated for lifetime membership. Full members wishing to nominate a fellow full member to lifetime membership status must submit a letter of recommendation to any board member outlining those individual's qualifications. If a two-thirds (2/3) majority vote of the board supports the recommendation, the nominee will be presented at the next general membership meeting for a vote. A vote of two-thirds (2/3) of the members present at the general membership is required to elect the nominee to lifetime status. Lifetime members are entitled to all privileges of the Club, including voting and holding office but pay no dues.

Article III - Meetings and Voting

Section 1. Club Meetings. <u>Monthly At least six</u> meetings <u>in a calendar year</u> will be held in Miami-Dade, Broward, or Palm Beach County. Consideration of meeting location shall be determined <u>in large part by where the majority of Club members</u> <u>reside</u> by the percentage of members residing in each county, with the number of <u>meetings per county each year to be in correlation with its percentage of members</u>. The date, hour, and place of meeting shall be designated by the President unless otherwise voted on by the majority of membership in attendance at the prior meeting. The Secretary shall give notice of each Club meeting at least ten (10) days prior to the date of the meeting. The quorum for such meeting shall be twenty percent (20%) of the voting membership or nine (9) voting members whichever is less. **2016 Specialty Shows:** The Club's next Specialty Shows will be March 12 and 13, 2016, and will be held concurrent with the Palm Beach County Dog Fanciers Association's shows.

The Club's 2016 specialty shows will be dedicated to the memory of Kathy Reeley.
